MIT Solve + the Jacobs Foundation

Solve is an initiative of MIT.

We launch open calls for exceptional and diverse solutions to the most pressing global challenges, from anyone, anywhere in the world.

The Jacobs Foundation seeks to improve children's learning and education by promoting the generation and translation of evidence into policy and practice.

As part of its 2030 Strategy, Jacobs Foundation supports the world's leading researchers and practitioners to understand how children learn and vary in their skills and behaviors. The Jacobs Foundation strengthens research and collaboration in both schools and educational technology (EdTech) to promote evidence-based practice.



What is LEAP?

LEAP pairs education organizations (LEAP **Project Hosts**) with a team of expert researchers and social entrepreneurs -**LEAP Fellows** - who lend their expertise to the organization for a 12-week part-time sprint (a "LEAP project"), providing them with tailor-made research recommendations that inform the organization's approach to strengthen the evidence base of their solution.





Eligibility requirements for Project Hosts

- Education organization (non-profit, for-profit, or hybrid models).
- Solution (a product or program) that aims to improve learning outcomes for children ages 2-12.
- Serve learners in Sub-Saharan Africa or Latin America.
- Solution is in the **pilot** or **growth** stage of development.
 - Pilot: The solution has been launched in at least one community, but is still iterating on design or business model. If for-profit, is generally working to gain traction and may have completed a fundraising round with investment capital. (Often 10+ users/direct beneficiaries).
 - **Growth:** An established solution available in one or more communities with a consistent design and approach, ready for further growth in multiple communities or countries. If for-profit, has generally completed at least one formal investment round (Seed stage or later). If nonprofit, has an established set of donors and/or revenue streams.

Benefits of serving as a LEAP Project Host

- Partner with a team of 3-4 researcher and social entrepreneur Fellows who apply their knowledge and skills to support your education solution's evidence journey;
- A final report that details tailor-made **research recommendations** (study designs, strategies, frameworks, and/or monitoring and evaluation tools) that inform your approach to strengthen the evidence base of your education solution;
- Professionally-managed **project facilitation provided by MIT Solve**, allowing you to focus solely on the most critical elements of the 12-week project;
- Valuable **networking** opportunities across the global cohort of LEAP Fellows and Project Hosts;
- A **\$5,000** stipend to the Project Host organization to compensate for time spent hosting the LEAP Project.



LEAP in practice: Successful Project Hosts

• Openness and humility to your assumptions being challenged and tested.

• Flexibility to potentially rethink your original research questions.

• Collaborative engagement with your Fellow team.

- O Level 1: You can describe what you do and why it matters, logically, coherently and convincingly.
- O Level 2: You capture data that shows positive change, but you cannot confirm you caused this.
- O Level 3: You can demonstrate causality using a control or comparison group.
- O Level 4: You have one + independent replication evaluations that confirms these conclusions.
- O Level 5: You have manuals, systems and procedures to ensure consistent replication and positive impact.

Keep in mind when describing your desired outputs that LEAP Projects take place over only 12 weeks with approximately four LEAP Fellows each working 6-10 hours per week.

Q&A

- I am interested in applying to one of Solve's Global Challenges, am I still eligible to apply for LEAP?
 - Yes, you can apply to Solve's Global Challenge and LEAP. Both Challenges are reviewed independently and advancing in one of the Challenges does not hinder or help your chances in advancing in the other Challenge.
- Will there be any in-person requirements to participating in LEAP?
 - No, all required LEAP programming will be virtual (Zoom, Slack, email).
- Can my organization submit more than one application/LEAP project for consideration?
 - We want your best LEAP project, so please only submit one application.
- What is the prerequisite financial status of the applying organization?
 - To be eligible to host a LEAP Project an organization must be an independently registered organization (for profit or non-profit) or have a fiscal sponsor who is eligible to receive funds on behalf of the applicant.





• What are the LEAP areas of focus?

- Eligible LEAP Project Hosts are education organizations with learning solutions that aim to improve learning outcomes for children ages 2-12 in Sub-Saharan and Latin American countries. The solution can be anything from an Ed-Tech product to a program that trains teachers.
- What is the scope of these projects?
 - LEAP Projects will take place over a 12 week sprint, staffed with 3-4 Fellows working 6-10 hours/week. The application asks several questions for you to detail your LEAP Project, so keep this in mind when outlining your desired outputs.
- I want to know at what depth or level of solution you are expecting. For example, I have a product that is currently used by one teacher to teach 10 students. Can I still apply?
 - It sounds like your solution is in the Prototype stage of development, which is not eligible for LEAP support. To be eligible for LEAP, your solution has to be in either the pilot of growth stage. Please see how those stages are defined in the <u>FAQ</u>.

Q&A

- Since we work with partner schools, would the Fellow team be willing to pilot or test some approaches within selected schools?
 - LEAP is intended to be a virtual program and there is no expectation that Fellows visit you in person. Although it's not common, if LEAP Fellows are based near you or are traveling near you there might be a possibility of them visiting the schools where you are implementing the recommendations.
 - Depending on the focus and needs of your project, Fellows may be interested in holding virtual workshops or focus groups with your staff or beneficiaries.
- What additional documents should an organization prepare for the application?
 - There are a few documents we ask you to upload as part of your application. An organizational chart that illustrates your staff capacity as well as your organization's Theory of Change or Logic Model are required.
 - It is optional to upload your organization's operating budget in document form, however it is required to answer what your organization's operating budget is.
 - If you are selected as a Project Host, you will be sharing documents and data with your Fellow team in order for them to carry out your project.
